Mayor Houser called the Public Hearing Regarding Proposed Budget FY 25/26 meeting to order at 6:30 PM.

Rose made a motion to close the public hearing at 6:32 pm, seconded by Richardson – 3 ayes.

Taylor made a motion to approve **Resolution 2025-178 (Appoint Position of Public Works Superintendent and Set Wages)**, seconded by Richardson. Roll Call 3 ayes: Johnson, Taylor, Richardson. 1 abstain: Rose.

Rose made a motion to designate the Avoca Journal Herald as the legal publication paper for the City of Carson, seconded by Taylor – 4 ayes.

Richardson made a motion to remove Aspen Arterburn from the position of Seasonal Part Time Mower/Trimmer, seconded by Johnson – 4 ayes.

Rose made a motion to approve **Resolution 2025-18 (Appoint Aspen Arterburn to the Position of Part Time Janitorial and Set Wages)** seconded by Johnson. Roll Call 4 ayes: Johnson, Rose, Taylor, Richardson.

Rose made a motion to approve the Temporary Use of Property Permit for Judge Richard Distillery for May 3, 2025, seconded by Taylor – 3 ayes. 1 abstain: Richardson.

Discussion was held regarding the draft the of the Carson Employee Handbook.

Resolution 2025-13 (Adopting the City of Carson, Iowa Employee Handbook Final Draft) was tabled until the next regular council meeting.

Rose made a motion to set the date of the Public Hearing Regarding the Proposed Budget Amendment for the current year for May 12, 2025, seconded by Taylor – 4 ayes.
