

ORDINANCE 267

AN ORDINANCE TO AMEND THE CODE OF ORDINANCES OF THE CITY OF CARSON, IOWA, BY AMENDING SECTION 69.06 ENTITLED "PARKING PROHIBITED" TO ADD NEW SUBSECTIONS 19 AND 20 TO SAID SECTION FOR THE PURPOSE OF ADDING PROVISIONS PERTAINING TO THE DESIGNATIONS OF AREAS WHERE STOPPING OR PARKING ARE PROHIBITED; REPEALING ANY AND ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT TO THE EXTENT OF SUCH CONFLICT; AND ESTABLISHING AN EFFECTIVE DATE

SUBSECTION AMENDED: CHAPTER 69, SECTION 69.06

BE IT ENACTED, by the City Council of the City of Carson, Iowa:

SECTION 1. PURPOSE. The purpose of this ordinance is to amend Section 69.06 of Chapter 69 entitled "Parking Prohibited".

SECTION 2. SUBSECTION AMENDED. Section 69.06 of the Code of Ordinances of the City of Carson, Iowa, shall be and is hereby AMENDED BY ADDING the following as Subsections 19 and 20 to Section 69.06:


- 19. At any place where official signs prohibit stopping or parking;

- 20. Upon such streets, bridges, or portions thereof in the City as the City Council by resolution designates as prohibited areas, and in areas where parking is prohibited, suitable signs shall be erected in such areas, or suitable markings shall be placed upon the street, curb, or sidewalk showing that parking is prohibited. The resolution establishing these no parking zones shall state whether this designation is permanent (full time) or seasonal (temporary).

SECTION 3. SEVERABILITY CLAUSE. If any section, provision or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional.


SECTION 4. WHEN EFFECTIVE. This ordinance shall be in effect from and after its final passage, approval and publication as required by law.

Passed by the Council on second reading the 10th day of March 2025.
Passed by the Council on third reading the 14th day of April 2025 and directions to the City Clerk to publish the Ordinance as approved.


